

Fundsmith Small Estate Form

This form is to be used when the value of the deceased client's account is below £20,000 and is to be completed by the personal representatives or, if the deceased did not make a will, the individuals who have the legal right to act on behalf of the estate, usually the next of kin. The Small Estate Form is to be completed where Grant of Probate or Grant of Letters of Administration (referred to generally below as Grant of Representation) are not being applied for.

- Please complete this form in black ink using **BLOCK CAPITALS**.
- The signing of the form will need to be witnessed by either a Solicitor, Commissioner of Oaths, Notary Public or a Justice of the Peace.
