Fundsmith Equity Fund Aim

The Fundsmith Equity Fund "The Company" will invest in equities on a global basis.

The Company's approach is to be a long-term investor in its chosen stocks. It will not adopt short-term trading strategies.

The Company has stringent investment criteria which the ACD, as investment manager, adheres to in selecting securities for the Company's investment portfolio. These criteria aim to ensure that the Company invests in:

- high quality businesses that can sustain a high return on operating capital employed;
- businesses whose advantages are difficult to replicate;
- businesses which do not require significant leverage to generate returns;
- businesses with a high degree of certainty of growth from reinvestment of their cash flows at high rates of return;
- businesses that are resilient to change, particularly technological innovation;
- businesses whose valuation is considered by the Company to be attractive.

Investors should be aware that the application of these investment criteria significantly limits the number of potential investments for the Company's portfolio. It is envisaged that the investment portfolio of the Company will be concentrated, generally comprising between 20 and 30 stocks.

The Company will not invest in derivatives and will not hedge any currency exposure arising from within the operations of an investee business nor from the holding of an investment denominated in a currency other than sterling.

Portfolio Comment for May 2012

During the month we initiated a position in McDonald's the fast food restaurant operator and franchisor. We are attracted to franchisors as they are able to grow utilising capital supplied by their franchisees. We believe McDonald's to be well run. The financial results fit our strict criteria with operating margins and return on capital of over 30% and a high rate of free cash conversion from profits. We also admire the no nonsense management reporting style and the fact that McDonald's has pushed its concept to be able to attract customers for any meal of the day and coffee in between, something which is clearly the envy of other fast food operators who are more closely associated with a particular dish or variety of food which is not easy to expand to other meals. The recent sharp fall in McDonald's stock price brought it into our valuation range and gave us a buying opportunity. The top 5 contributors in the month were Dr Pepper Snapple, Pepsico, Colgate Palmolive, Sigma Aldrich and Procter & Gamble. The top 5 detractors in the month were Schindler, Imperial Tobacco, Unilever, Reckitt Benckiser and Serco.
