Selfie process

To make the process of providing your identity documents as stress free as possible, you can verify your identity by sending in a 'selfie' photo holding your ID card, Driving Licence or the photo page of your passport. This will have to meet the following criteria to be acceptable:

- · Your face should be clearly recognisable in both the photo and in the identity document
- A separate picture of the document should be sent ensuring all the information is clear and legible. Please ensure the document is not obstructed by fingers/thumbs
- This should be accompanied by another picture of a valid proof of address document dated within 3 months
